THE WILLIAM BRANDENBURG JUNIOR FAMILY

William Brandenburg Junior was one of my favorites. I imagine him as a tall, dark, rawboned and kindly man, although he may not have been like that at all. From papers he signed, and books and a box of tricks he owned, he was educated and fond of tricks.

His tombstone, and those of his second wife Christina, and their son Abner, all matched. They were of fine quality pinkish-brown slate, with a circular part at the top depicting a willow tree, and decoration on each of the four corners on the main part of the stone. At the time I visited, there was a homemade cement stone flat on the ground with William Brandenburg inscribed on it, and a Revolutionary War marker next to it. The three original stones were piled next to the homemade stone, with Abner's on top, and because they were so heavy, I could not move his to read the other two. Hopefully, since my visit, the cemetery board had restored them to their places, because there are not that many Revolutionary War soldiers buried in Ohio.

Nowhere was William Junior's occupation given. Because of all the furniture and tools he owned, both in Maryland and Ohio, and because he lived in the village of New Carlisle at the end of his life, he might have been a cabinet maker. He may also have been a weaver (things found in his estate) or farmed and moved to New Carlisle after he retired.

He served as a "Minute Man" in the Revolutionary War, even though his duty was not very exciting. He fought in no battles, but mainly chased Tories and guarded British prisoners. His documents from that war, tell us more about his life.

We are given a peek into what he owned by the sales he made in Frederick County, possibly when he was planning to move west, and what was appraised, and sold at his estate sale. He was born in New Jersey, possibly where his family were indentured, and went from there to Maryland, and from there stopped off for four years in Fayette County, Pennsylvania, where his cousins, John Conrad Brandeburg/Brandeberry and Barbara (Brandenburg) Franks lived. Then he continued on to Montgomery County, Ohio, where his three oldest sons had settled, and finally ended up in Clark County, Ohio.

It was possible to learn so much about him and his family - and yet so little. This family was pieced together from various records. The ones who lived are known, from William Junior's estate. The census records for the family were from 1790 through 1830, but those censuses do not give names of children or exact years of birth, so it was necessary to do some guessing. 1850 and 1860 census records were found for some of the children, so their ages could be calculated within a year's time.

However, in his census records, there were at least three daughters and a son, whose names are unknown. All the daughters may have married because they were old enough when they disappeared from William Junior's census records, and the son was old enough to be on his own, when his name disappeared from the census. Possibly one or more of them died young. The persons shown could have been servants or orphans William took in, but with so many children of his own to help with the work, it is doubtful.

William Junior's first wife was said to be named Catharine, last name unknown. Some genealogists think her name was Catharine Bey, but I found records for Catharine Bey in German records; she married a Brandenburg man and died in Germany. One or two genealogists said they found her surname and it was spelled variously as "Bussard" or "Buzzard." William Junior's sister, Anna Maria Brandenburg married Samuel Bussard Junior, in Frederick County, Maryland, in 1774, so William Junior's wife could have been Samuel's sister.

William Junior's first wife, Catharine Bussard had died by 1790 as she is not found in that year's census. The census shows only William Junior and his three sons living in the household. The youngest son, William Henry III, had been born in February 1785 and was baptized in May of that year with both of the parents as the baptismal sponsors, so the mother must have died between May 1785 and 1790.

William Junior and his second wife Christina Martin were married on 15 Jun 1795, shown by their marriage license.

Of the children, Cooper and Olivia (Brandenburg) Lane lived in Madison County, Ohio, in 1837, as did Mary Ann and her husband, Moses Byers. Then the Lanes were lost. The two youngest boys, Ebenezer P. and Joel G., went with Enoch, to Fountain County, on the western edge of Indiana. There they married. Ebenezer went on into Central Illinois (his census and other records), but I cannot find his sketch right now. Joel G. Brandenburg (whose records are also missing at present) probably ended his life in Warren County, Indiana, which is just north of Fountain County.

From William Junior's estate, it appeared that the rest of the family did not know where William Brandenburg III was, but he was found in Erie County, Ohio, on Lake Erie. Later, however, his family must have been in contact with them, because some of his heirs were at the meeting in Dayton, Ohio, in the late 1800s, when they were trying to obtain a fortune that supposedly belonged to their ancestors in Germany.

William Brandenburg Junior's Census Records, Hayes, on microfilm or in book form.

In the 1790 Frederick County, Maryland, Census, William Junior was living next door to his father, William Henry Brandenburg Senior, in Middletown Valley. Living with him were his three oldest sons, but their mother must have died before the census, because no "female" was listed.

In the 1800 Frederick County, Maryland, Census, his three sons by his first wife were no longer living with him, but he had a second wife and 4 children, 2 sons and 2 daughters, all under the age of 10 years old. There were 2 females aged 10-16, that may have been servants or relatives.

In the 1810 Frederick County, Maryland, Census, he had his third wife and 4 sons and 3 daughters living with him. He lived three houses from his brother, Henry, and 6 houses from his brother, John.

In the 1820 Clark County, Ohio, Census, he was living in Bethel Township, and his third wife and 5 sons and 5 daughters.

In the 1830 Clark County, Ohio, Census, his third wife was 50 to 59 years old. Persons I believe to be Aaron and his wife and son; Abner; Olivia; Catharine; and Ebenezer P. or Joel G. were living with him.

By the 1840 Clark County, Ohio, Census, both William Junior and his third wife were dead (his estate, their tombstones).

KNOW ALL MEN by these presents, that I, William Brandenburgh, of Frederick County, in the State of Maryland, for and in Consideration of the sum of \$65 current money, to me in hand paid by Adam Michael, one Bay mare with a man's Saddle, Singletrees, and Geers [sic], one red and white heifer - two years old, two feather beds and their furniture, one chaff bed and furniture, one walnut chest, one walnut Table, five split-bottomed chairs, 3 Iron potts [sic] and one dutch oven, one Skillet & five pewter plates, 3 pewter basons, and one pewter dish, two tin buckets, two wooden buckets, and one piggen, with all other of my house and kitchen furniture, one Gun and a pair of iron fire tongs with a fore plain, a Jack plain, and 5 other Small plains.

TO HAVE AND TO HOLD the said bargained and sold premises unto the said Adam Michael, his heirs, executors, administrators and assigns, and the said William Brandenburgh, for myself, my executors and administrators, shall and will warrant and forever defend against all persons, by these presents, the said bargained premises unto the said Adam Michael, his heirs and assigns. In witness whereof I, the said William Brandenburgh, do hereunto Set my hand and affix my seal this 13th day of January, 1808.

TO HAVE AND TO HOLD the said one bay Gelding unto him, the said Jacob Late, his heirs, Executors, administrators or assigns forever, and the said William Brandenburg for myself, my heirs, Executors and administrators, the said one bay Gelding unto him the said Jacob Late, his Executors, administrators and assigns, against all and every person or persons whatsoever, shall and will warrant and forever defend by these presents, the said one bay gelding to him the said Jacob Late, his heirs and assigns, according to the true intent and meaning hereof, and the act of assembly in such case made & provided. In Witness whereof I have hereunto set my hand and Seal the 3th [sic] day of August, 1809.

Note: The above mortgage, along with William Junior's estate, gives a more exact date for his death. It also proves that John Brandenburg, who married Phoebe Gorner, was indeed the son of William Henry Brandenburg Senior, because William, a known son of his, loaded money to him. I do not believe he would have loaded him money unless he was his nephew. John Brandenburg (married Phoebe Gorner) died before 1834, and William Junior who lived in the next county to Montgomery, probably acted in place of a father to him after his own father's death.

William Brandenburg Junior's Revolution War Pension Record (see #163), some punctuation and paragraphs added for clarity. "---" means I could not read the word:

The State of Ohio, Clark County, SS:

On this second day of October, A. D. 1832, personally appeared in open court, before the Court of Common Pleas, Clark County, the State of Ohio, now sitting, William Brandenburg, residing at Bethel Township, in Clark County, aforesaid, on this the 5th day of October, A. D. 1831, who having been duly sworn according to law, doth on his oath make the following declaration.

That he enlisted in the service of the United States under the following warrant officers and served, as interview stated, some time in the month of June in seventeen hundred and eighty-one (1781) as a Volunteer, and served under Captain Michael Troutman of Frederick County, in the State of Maryland, who commanded a company of Minute Men, the place of rendezvous of the company was Middletown, Frederick County. The company remained at the place of rendezvous and in the neighborhood and

engaged in protecting the country from the Tories untill [sic] sometime in September, when the company was ordered to take charge of a company of British prisoners. The company was marched to --- Spring --- on the Potomac River, where they took charge of the prisoners, as he believes upwards of one thousand in number, The prisoners were under the guard of Captain Troutman's company of Minuet Men, Captain Hilary's company of Minute Men, Captain Chaplin's company of Minute Men, and one other company of Minute Men, the name of the Captain not now recollected. Lieutenant Colonel Abner Ritche, of Frederictown commanded the whole.

They were marched to Fredericktown, in Frederick County in the State of Maryland, he and the company in which he belonged, Maryland State, remained stationed at Fredericktown untill [sic] the expiration of the term for which he volunteered, which was six months, when he was discharged a few days before Christmas of the same year. At the time he volunteered, he was in no battles, performed in no Marches other than as above stated. He was a guard with Colonel Stricker and Major Weltner of the Dutch [German] Battalion, as it was called, raised in Frederick County.

He has no remaining evidence of his Services in recorded or written discharge, when his term of service expired, but it has been lost for many years and he cannot state where or how it was lost. He knows of no person whose testimony --- [part I cannot read] person who can testify to his service, except Adam Coblentz, whose affidavit accompanies this declaration.

We, Samuel Kyle, a clergyman residing in the county of Miami in the State of Ohio, and William Brandenburg, residing in Bethel Township, Clark Count, and one of the appointed judges of the Court of Common Pleas of Clark County, hereby certify that we believe --- [part I cannot read] who has subscribed and sworn to the above declaration, that we believe him to be seventy-three years old as stated. That he is known and believed in the neighborhood where he resides to have been a soldier of the revolution, and that we concur in that opinion.

In answer to the pension to him by the United States:

That he was born in Middlesex Township, Middleton County, in the State of New Jersey, in the year 1758, on the 8th day of October. That he has a record of his age in his Bible, which record was made from a similar one in his father's Bible.

When called upon to answer, he lived in Frederick County as stated in the body of this declaration. He continued to reside there until in 1812, when he removed to Fayette County, Pennsylvania. He remained at the latter place until the Spring of 1816, when he removed to Montgomery County in the State of Ohio, and remained there until the fall following, when he removed to Bethel Township in Clark County. And the Court further

certifies that it appears to them that Samuel Kyle who had attended the proceedings, being a clergyman residing in Miami County in the State of Ohio --- [cannot read].

He --- [cannot read part] established in the body of his declaration. He recalled the officers mentioned in the body of his declaration and also Major Bailey of the Battalion of British, when stationed at Fredericktown. He received a written declaration from Captain Troutman, which has been lost, but where or when he does not recollect. He named in addition to the two before-named; John Paul, Andrew Reyburn, Esq., Elnathan Cory Esq., John Hay, James ---, Esq., as persons who may testify to this.

Note: I checked a New Jersey map, and William Junior got it backwards in his pension application. The county was Middlesex, and the township was Middleton, unless the names have changed since he was living.

Letter Concerning William Brandenburg Junior's Revolutionary War Service (in his service file at the National Archives, Washington D. C.)

Dear Madam:

Reference is made to your letters in which you requested the Revolutionary War records of Jacob and William Brandenburg.

Revolutionary War data furnished by this office are obtained from claims made to the United States for pension and bounty land, based upon military service or soldiers in that war. A search of the records show no such claims on file on account of the Revolutionary War service for Jacob Brandenburg; the surname has been searched under similar spellings. It is suggested as a possible means of securing information relative to the military record of this soldier, that you apply to the Adjutant General, War Department, Washington D. C.

The data which follow were obtained from the papers on file in pension claim S.2405, based upon the military service of William Brandenburg, during the War of the Revolution. William Brandenburg was born October 8, 1758, in Middlesex Township, New Jersey, names of his parents not given. While residing about three miles from Fredericktown in Frederick County, Maryland, he volunteered in June 1781, served six months in Captain Richard Troutman's company, Lieutenant Colonel Abner Rithcie's Maryland Regiment, was out in pursuit of Tories and was a guard to British prisoners in Fredericktown, Maryland.

The soldier, William Brandenburg, continued to live in Frederick County until 1812, when he moved to Fayette County, Pennsylvania. In the spring of 1816, he moved to Montgomery County, Ohio, and in the following fall, he moved to Bethel Township, Clark County, Ohio. He was allowed pension on his application, executed October 2, 1832, then a resident of said Bethel Township. There are no data in this claim relative to the family of William Brandenburg. In order to obtain the date of last payment of pension, the name and address to whom sent, and possibly the date of death of this pensioner, you would apply to the Comptroller General, General Accounting Office, Records Division, Washington D. C., citing the following data:

William Brandenburg; Certificate #7808; Issued April 6, 1833; Rate \$20.00 per annum; to commence March 4, 1831; Act of June 7, 1832; Ohio Agency.

PETITION SUIT TO SETTLE ESTATE

Note: Notice at one point Henry Brandenburg took over the administration of his father's estate from Aaron. I don't know if that was when Aaron moved to Shelby County, Indiana, but it may have been.

NEW CARLISLE

New Carlisle is reached by taking U. S. Route 70 east from U. S. Route 75, just north of Dayton, Ohio, and then taking County Route 235 north into New Carlisle. The village main street is on Route 235, with the cemetery where William Brandenburg Junior is buried, just south of the village. There was a large brick firehouse in the village where two streets came together to form a “V” but I cannot remember much else.
