AFFIDAVIT OF FACTS CONCERNING THE IDENTITY OF HEIRS

Before me, the undersigned authority, on this day personally appeared James Roberts, "Affiant," who, being first duly sworn, upon oath states:

- 1. My name is James Roberts, and I live at 7725 Strolling Ave., San Antonio, Bexar County, Texas 78233. I am personally familiar with the family and marital history of Carl J. Kollenberg, also known as Carl Joseph Kollenberg and C. J. Kollenberg, the "Decedent," and I have personal knowledge of the facts stated in this Affidavit.
- 2. I am the Decedent's nephew by marriage, and I knew the Decedent and his family all of my life. The Decedent's wife, Kathryn Jessie Kollenberg, also known as Jessie Kollenberg, and my mother, Ann Shore Roberts, were sisters. The Decedent died on August 26, 1996, at the age of 85 years in San Antonio, Bexar County, Texas. At the time of his death, the Decedent's residence was 817 Greer Ave., San Antonio, Bexar County, Texas 78210.
- 3. The Decedent had one marriage to Kathryn Jessie Kollenberg, also known as Jessie Kollenberg. The Decedent was married to Jessie Kollenberg on August 19, 1935, in San Antonio, Bexar County, Texas, and was married to her at the time of his death on August 26, 1996, in San Antonio, Bexar County, Texas. The Decedent had no other marriages.
- 4. One child was born to the marriage of the Decedent and Jessie Kollenberg, namely Carl J. Kollenberg, Jr., who was born on March 10, 1944, in San Antonio, Bexar County, Texas, and who currently resides at 5563 Abilene Trail, San Antonio, Bexar County, Texas 78222.
- 5. The Decedent did not have or adopt any other children and did not take any other children into Decedent's home or raise any other children.
- 6. Decedent died leaving his Last Will and Testament signed on July 4, 1979, which is attached to this Affidavit.
- 7. No probate of this Will was had, nor has there been any administration of the Decedent's estate, there being no necessity therefor.
- 8. Decedent left no debts that are unpaid, and there are no unpaid estate or inheritance taxes.

- 9. On the date of death, the Decedent owned an interest in the following real property:



KNOW ALL MEN BY THESE PRESENTS:

That I, CARL J. KOLLENBERG, of the County of Bexar, State of Texas, being in good health, of sound and disposing mind and memory, and not being actuated by any duress, menace, fraud, mistake, or undue influence, do make, publish and declare this to be my LAST WILL AND TESTAMENT, hereby revoking all wills and codicils previously made by me.

FIRST: I direct that all my just debts and expenses of my last illness, funeral, and burial be paid as soon after my death as practicable. Further I direct that arrangements for my funeral be made and carried out as directed by my executrix.

SECOND: I give, devise and bequeath all of my estate and property of which I might be seized of, possessed, or to which I may be entitled at the time of my death, wherever situated or of whatever nature, be it real personal or mixed, including lapsed legacies and any property over which I may have a power of appointment, to my beloved wife, KATHRYN JESSIE KOLLENBERG, being confident that she will use my estate to the best interests of herself and our children.

THIRD: In the event my said wife should predecease me, I give, devise and bequeath all of my estate and residue, if any real, personal and mixed, unto my son, CARL J. KOLLENBERG, JR. as well as any other children hereafter born of our marriage or legally adopted by me, absolutely and forever, in equal portions to share and share alike.

FOURTH: I hereby appoint my beloved wife, KATHRYN JESSIE KOLLENBERG, as Independent Executrix of this my LAST WILL AND TESTAMENT, and I request she be permitted to serve without bond or surety thereon and without the intervention of any court or courts, except as required by law. I authorize and empower my said executrix in her absolute discretion, to sell, exchange, or convey, transfer, assign, mortgage, pledge, lease, or rent the whole or any part of my real or personal estate, to invest, reinvest, or retain investments of my said estate, and to perform all acts to execute all documents which said executrix may deem necessary, convenient, or proper in regard to my property. I further direct that my Executrix shall receive the prevailing rate for all the services rendered by her in that capacity to my estate. In the event she predecease me, or for any reason fails or ceases to act as Executrix, I hereby nominate, constitute and appoint in her place and stead, as Executor, CARL J. KOLLENBERG, JR., to serve without bond.
